## SECTION 3 - HAZARDS IDENTIFICATION

EMERGENCY OVERVIEW - Clear liquid with slight amine odor. Spills are very slippery. Avoid contact with skin eyes and clothing.

### POTENTIAL HEALTH EFFECTS

EFFECTS OF OVEREXPOSURE - EYE CONTACT: Prolonged or repeated eye contact may cause irritation.

EFFECTS OF OVEREXPOSURE - SKIN CONTACT: Prolonged or repeated skin contact may cause irritation.

EFFECTS OF OVEREXPOSURE - INHALATION: None expected.

EFFECTS OF OVEREXPOSURE - INGESTION: May be harmful based on animal studies.

Some initial conjunctive blistering was noted in 3 of 6 animals but, this condition completely disappeared by the end of the observation period.
